To qualify you must currently be in receipt of any one of the following:

- * Income Support
- * Income Based Job Seeker's Allowance
- * Income related Employment & Support Allowance
- * Support under part 6 of the Immigration & Asylum Act 1999
- * The guaranteed element of State Pension Credit
- * Child Tax Credit, **provided they are not also entitled to Working Tax Credit**, and have an annual gross income of no more than £16,190 as assessed by Her Majesty's Revenue and Customs (HMRC). (Where a parent is entitled to Working Tax Credit Run-on - the payment someone receives for a for the 4 weeks after they stop qualifying for Working Tax Credit—their children are entitled to free school meals.
